ORDINANCE NO. 2015-O-___

AN ORDINANCE AMENDING THE ORDINANCE PROPOSING THE ESTABLISHMENT OF A VILLAGE OF LONG GROVE SPECIAL SERVICE AREA FOR PROVIDING PUBLIC WATER TO THE HISTORIC DOWNTOWN AREA PORTION OF THE VILLAGE DOWNTOWN/IL RT. 83 REDEVELOPMENT DISTRICT

WHEREAS, on 8 September 2015, the President and Board of Trustees (the "**Village Board**") of the Village of Long Grove, an Illinois municipal corporation (the "**Village**"), adopted Ordinance No. 2015-O-19, being "An Ordinance Proposing the Establishment of a Village of Long Grove Special Service Area For Providing Public Water to the Historic Downtown Area Portion of the Village Downtown/IL Rt. 83 Redevelopment District" (the "**Proposing Ordinance**"); and

WHEREAS, the Proposing Ordinance initiated the process for a potential special service area to extend public water to the Village's downtown area (the "**Proposed SSA**"); and

WHEREAS, the Proposing Ordinance called for a public hearing on the Proposed SSA to commence on 13 October 2015 at the Village Hall (the "**SSA Hearing**"); and

WHEREAS, the Village Board subsequently learned that it might not be able to gather for a meeting on 13 October 2015; and

WHEREAS, due to the uncertainty of the date for the SSA Hearing, the Village did cause a public notice to be published on 28 September 2015 (the "**SSA Hearing Notice**") in accordance with the Special Service Area Law, 35 ILCS 200/27-5 *et seq.* (the "**SSA Law**"); and

WHEREAS, the Village Board has since determined that the SSA Hearing will in fact commence on ~~[13 October 2015]~~**[14 October 2015]**, and that the SSA Hearing will be held at ~~[the Village Hall, 3110 Old McHenry Road, Long Grove, Illinois]~~**[the Kildeer Countryside Elementary School, 3100 Old McHenry Road, Long Grove, Illinois]**; and

WHEREAS, the Village Board hereby amends the Proposing Ordinance as hereinafter set forth to reflect the public notices and to confirm the date for the SSA Hearing;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, COUNTY OF LAKE, AND STATE OF ILLINOIS, as follows:

SECTION ONE. **Recitals.** The foregoing recitals are incorporated herein as findings of the President and Board of Trustees.

SECTION TWO. **SSA Hearing Date.** As set forth in Section 4(a) of the Proposing Ordinance, the Village Board reconfirms that the SSA Hearing will be held on the 13th day of October 2015, at 7:00 p.m., in the Board Room of the Long Grove Village Hall, 3110 Old McHenry Road, Long Grove, Illinois.

[ALTERNATIVE #2]

SECTION TWO. **SSA Hearing Date.**

(a) The Village Board hereby determines that the SSA Hearing (which was originally scheduled for the 13th day of October 2015, at 7:00 p.m., in the Board Room of the Long Grove Village Hall, 3110 Old McHenry Road, Long Grove, Illinois) will be continued till the 14th day of October 2015, at 7:00 p.m., at the Kildeer Countryside Elementary School, 3100 Old McHenry Road, Long Grove, Illinois.

SECTION THREE. **Ratification of SSA Hearing Notice.** The Village Board hereby ratifies the SSA Hearing Notice as published on 28 September 2015, including without limitation the inclusion in such notice of the following passage:

PLEASE TAKE NOTE: The Village Board may be required to continue the public hearing from Tuesday, 13 October 2015, at 7:00 p.m. in the Board Room of the Long Grove Village Hall, 3110 Old McHenry Road, Long Grove, Illinois, to Wednesday, 14 October 2015, at 7:00 p.m., at the Kildeer Countryside Elementary School, 3100 Old McHenry Road, Long Grove, Illinois. In the event that the public hearing is continued, the Village will:

- (i) Post on the exterior door of the Board Room at the Village Hall the fact that the hearing will be continued, along with the information of the date, time, and location for the continued hearing. Such posting will be effected no later than 5 p.m. on 9 October 2015; and
- (ii) Post on the Village website (www.longgrove.net) the fact that the hearing will be continued, along with the information of the date, time, and location for the continued hearing. Such website posting will be effected no later than 3 p.m. on 9 October 2015.

If the hearing will proceed on 13 October 2015 as originally planned, no such postings will be made.

SECTION FOUR. Continued Effect. Except to the extent that *[(i) the SSA Hearing is re-scheduled and (ii)]* the notice of the SSA Hearing has been prepared to account for the potentiality of re-scheduling the SSA Hearing as set forth above, the Proposing Ordinance shall remain in full force and effect.

SECTION FIVE. Effective Date. This Ordinance shall be in full force and effect immediately from and after its passage and approval.
