**AN ORDINANCE ADOPTING THE TAX LEVY FOR  
VILLAGE OF LONG GROVE SPECIAL SERVICE AREA NO. 2  
(Long Grove Commons)**

**WHEREAS**, on November 22, 2005, pursuant to Ordinance No. 2005-O-34, the Village of Long Grove established the Village of Long Grove Special Service Area Number 2 ("**SSA No. 2**"); and

**WHEREAS**, Ordinance No. 2005-O-34 authorizes the Village to levy and extend taxes upon real property within SSA No. 2 on an annual basis and pursuant to a Special Tax Roll; and

**WHEREAS**, the President and Board of Trustees have determined that it is necessary, appropriate, and in the best interests of the Village and its residents to levy and extend taxes upon real property within SSA No. 2, as set forth in this Ordinance;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

**SECTION ONE:**      **Recitals.** The foregoing recitals are incorporated into this Ordinance as findings of the President and Board of Trustees.

**SECTION TWO:**      **Tax Levy.** Pursuant to Ordinance No. 2005-O-34, the Village of Long Grove hereby levies **\$18,328.07** in taxes for the fiscal year beginning May 1, 2016 and ending April 30, 2017, against the real property within SSA No. 2 in accordance with the chart attached to this Ordinance as Exhibit A. In the event that such levy is found to exceed any limitation on the Village's authority to levy taxes against the real property within SSA No. 2, then the levy shall be deemed to be the maximum amount permitted by law.

**SECTION THREE:**     **Filing.** The Village Clerk is hereby authorized and directed to file a certified copy of this Ordinance with the Lake County Clerk on or before December 20, 2016.

**SECTION FOUR:**     **Effective Date.** This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
