(Office Furniture & Equipment)

**WHEREAS**, the Village of Long Grove (the "Village") is the owner of the personal surplus property listed on the attached property hereto, and by this reference incorporated herein, as **Exhibit A**.

**WHEREAS**, the Village desires to sell the Property; and

**WHEREAS**, pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees of the Village of Long Grove find that the Property is no longer necessary or useful to the Village of Long Grove, and the best interests of the Village of Long Grove will be served by its sale or conversion;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE**, as follows:

**SECTION ONE: Recitals.** The foregoing recitals are incorporated into and made a part of this Ordinance by this reference.

**SECTION TWO: Transfer of Property.** Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees of the Village of Long Grove authorize the sale or conversion of the Property.

**SECTION THREE: Authority of the Village Manager.** The Village Manager is hereby authorized and directed to sell the Property by means of sealed or open bids, auction, or any other lawful means. Upon the sale of the Property, the Village Manager is authorized and directed to convey and transfer title for the Property to the purchasers.

**SECTION FOUR: Effective Date.** This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form in the manner provided by law.
