**AN ORDINANCE AMENDING TITLE 1, CHAPTER 5 OF THE  
LONG GROVE VILLAGE CODE REGARDING ELECTED OFFICIAL COMPENSATION**

**WHEREAS**, pursuant to Section 3.1-50-5 of the Illinois Municipal Code, 65 ILCS 5/3.1-50-5, the President and Board of Trustees have authority to fix by ordinance the compensation of elected officials, provided that salaries or other compensation shall not be increased or diminished so as to take effect during the term of any officer holding an elective office; and

**WHEREAS**, the Village President, Village Trustees, and Village Clerk currently serve the Village on a voluntary basis without compensation; and

**WHEREAS**, because of the many demands placed upon the Village President (including expenses relating to the discharge of the duties of Village President that have not routinely been reimbursed by the Village), the Board of Trustees has determined that service in the office of Village President should be accompanied by compensation in the amount of \$1,200.00 per month; and

**WHEREAS**, pursuant to Section 1-8-2 of the Village Code, the current term of office of the Village President shall expire in May 2017; and

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, COUNTY OF LAKE, STATE OF ILLINOIS, AS FOLLOWS:**

**SECTION ONE.**    **Recitals.**    The foregoing recitals are incorporated into this Ordinance as the findings of the President and Board of Trustees.

**SECTION TWO.**    **Amendment to Chapter 5, Title 1 of the Village Code.**  
Chapter 5, entitled "Village President and Board of Trustees," of Title 1, entitled

“Administrative,” of the Village Code is hereby amended by adding a new Section 1-5-2, which new Section 1-5-2 shall hereafter be and read as follows:

**1-5-2 Compensation of President and Board of Trustees.**

- (A) Beginning June 1, 2017, the Village President shall receive compensation in the amount of One Thousand Two Hundred Dollars (\$1,200.00) per month. Such amount is intended, *inter alia*, to cover all out-of-pocket and incidental expenses of the Village President related to his or her service to the Village.
- (B) Trustees of the Village shall serve without compensation.
- (C) Nothing in this Section shall be construed as making the Village President or any Trustee of the Village as a Village employee. Neither the Village President nor any Trustee shall be entitled to any of the benefits available to or otherwise conferred upon employees of the Village, including without limitation health or life insurance or retirement benefits.
- (D) The Village’s annual budget shall include sufficient appropriations to meet the obligations of the Village as set forth in Section 1-5-2(A). Nothing in this Section shall limit the powers of the Village’s corporate authorities to authorize the reimbursement of any elected official of the Village for expenses incurred in service to the Village.

**SECTION TWO.** **Effective Date.** This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
