RESOLUTION NO. 2015-R-14

RESOLUTION APPROVING A PURCHASE OF ROCK SALT

WHEREAS, the Village has determined that it desires to purchase rock salt through the State of Illinois Joint Purchasing Requisition Program ("**Rock Salt Purchase**"); and

WHEREAS, the Village Manager has recommended that the Village approve a proposal through the Lake County Bid 14040 Bulk Rock Salt NASC for the Rock Salt Purchase in a total expenditure amount not to exceed \$57,136.00; and

WHEREAS, the President and Board of Trustees, being fully advised in the premises, have determined that it is in the best interests of the Village and its residents to approve the Recommended Bid;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: Recitals. The foregoing recitals are hereby incorporated herein as findings of the Village Board of Trustees.

Section 2: Approval. The President and Board of Trustees hereby approves the Recommended Proposal at a total expenditure not to exceed \$57,136.00 and authorizes the Village Manager to execute a contract therefor; provided that the Village first receives an executed contract in a form acceptable to the Village Manager in consultation with the Village Attorney.

Section 3: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.



2015 Bulk Rock Salt Bid Opportunity

Dear Mayors and Managers:

Join Lake County's Bulk Rock Salt Contract and get ahead of the State Salt Bid for next year's snow season.

The benefits:

Secure pricing and obtain potential cost savings - State bid prices range from \$75 to \$130 per ton. Lake County's contract will provide pricing from \$67.14 to \$71.42 per ton.

Get discounts for early delivery - \$2 off a ton for orders placed before Nov. 1.

Last year, Lake County and 26 other units of government participated in a joint salt bid and purchased 43,400 tons of salt. Due to the success of this effort, a number of communities approached us about participating in the future. As we discussed contract terms for the second year, Lake County Purchasing was able to get the vendor to agree to allow communities - who did not originally participate - to do so for next year.
