**AN ORDINANCE CREATING THE DEPOSITORY FUND FOR  
VILLAGE OF LONG GROVE MOTOR FUEL TAX ALLOTMENTS**

**WHEREAS**, the Village of Long Grove receives motor fuel tax revenue allotments from the Illinois Department of Transportation (the "**Department**") pursuant to the Illinois Revenue Code, 35 ILCS 505/8(e); and

**WHEREAS**, the Village must use its motor fuel tax revenue allotment solely for the specific purposes identified in the Illinois Highway Code, 605 ILCS 5/7-202, *et seq.*; and

**WHEREAS**, the purposes for which the Village may use motor fuel tax revenue relate to construction and maintenance of municipal streets, pedestrian paths and crossings, traffic signals and signs, storm sewers, and other road-related projects that benefit the general public; and

**WHEREAS**, the Village, acting as the local administrative authority for the Department, must hold and expend motor fuel tax revenue allotments for the benefit of the citizens of the State and the general public, as provided by State law, and

**WHEREAS**, the Department distributes motor fuel tax revenues only to municipalities that expend such funds in strict compliance with the Illinois Highway Code, 605 ILCS 5/7-202, *et seq.*, and in a manner that is satisfactory to the Department; and

**WHEREAS**, the Corporate Authorities of the Village now hereby find that it is necessary to create a special fund to receive the Village's allotment of motor fuel tax revenues, however received;

**NOW THEREFORE BE IT ORDAINED**, by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

**SECTION ONE: Recitals.** The foregoing recitals are by this reference incorporated into and made a part of this Ordinance as if fully set forth.

**SECTION TWO: Establishment of Motor Fuel Tax Allotment Depository Fund.** A special fund shall be, and is hereby, established to receive motor fuel tax revenues payable to the Village. This fund shall hereafter be known as the "Motor Fuel Tax Allotment Depository Fund." The Motor Fuel Tax Allotment Depository Fund shall supersede any existing accounts or funds designated or used for deposit of motor fuel tax revenues.

**SECTION THREE: Deposit of Motor Fuel Tax Revenues.** The Corporate Authorities shall deposit any and all motor fuel tax revenues received for the purpose of paying costs and obligations as provided by the Illinois Highway Code, 605 ILCS 5/7-202, *et seq.*

**SECTION FOUR: Effective Date.** This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
