ORDINANCE NO. 2013-O-\_\_\_

AN ORDINANCE PARTIALLY RESCINDING ORDINANCE NO. 2013-O-17,  
ESTABLISHING A POLICY FOR  
DEFINING VILLAGE-FUNDED ROADS

WHEREAS, on 12 November 2013, the President and Board of Trustees of the Village of Long Grove (the "*Village Board*") adopted Ordinance No. 2013-O-17, being:

AN ORDINANCE ESTABLISHING A POLICY FOR  
DEFINING VILLAGE-FUNDED ROADS

(hereinafter, the "*Non-Thoroughfare Policy Ordinance*"); and

WHEREAS, the members of the Village Board have given further consideration to the provisions of the Non-Thoroughfare Policy Ordinance; and

WHEREAS, the Village Board has determined that the best interest of the Village and its residents will be served by rescinding and repealing in part the Non-Thoroughfare Policy Ordinance, but retaining the identification of thoroughfare roads as set forth in the Non-Thoroughfare Policy Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS, as follows:

SECTION ONE.      RECITALS. The foregoing recitals are incorporated as if fully set forth in this Ordinance.

SECTION TWO.      Partial Rescission of Non-Thoroughfare Policy Ordinance.

The

(a) Partial Rescission. Except as provided in Section 2(b) of this Ordinance, the Village Board hereby adopts and ~~approved~~approves this ~~ordinance~~Ordinance rescinding the Non-Thoroughfare Policy Ordinance, being Ordinance No. 2013-O-17.

(b) Re-Adoption and Approval. Notwithstanding Section 2(a) of this Ordinance, the Village Board hereby re-adopts and approves by reference that portion of Exhibit B to

Ordinance No. 2013-O-17 that is set forth in the Table labeled as "Thoroughfare Roads 82,151 Lineal Feet (LF)." In all other respects, Exhibit B is hereby repealed.

(c) Implementation. Upon the effective date of this Ordinance, the Non-Thoroughfare Policy Ordinance shall no longer have any force or effect, except as provided in Section 2(b) of this Ordinance, and the Village Manager and Village Engineer are hereby authorized and directed to update Exhibit B [as referenced in Section 2(b) above] to reflect the changes referenced in Section 2(b) above.

**SECTION THREE. EFFECTIVE DATE.** This Ordinance shall become effective immediately following its passage and approval in the manner provided by law.
