**RESOLUTION NO. 11-R-029**

**A RESOLUTION TO REPAVE A PORTION OF  
EAST CUBA ROAD**

WHEREAS, the southern half of East Cuba Road from S. Kreuger Road to the end of the Tall Oaks subdivision is under the jurisdiction of the Village of Kildeer; and

WHEREAS, the Village Engineer for Kildeer recommends repaving of a portion of East Cuba Road and has obtained a cost estimate for that work; and

WHEREAS, the Village of Long Grove has entered into a contract to repave a portion of East Cuba Road that includes the northern half of East Cuba Road from S. Kreuger Road to the end of the Tall Oaks subdivision; and

WHEREAS, the Village of Long Grove offered to include Kildeer's portion of East Cuba Road as part of its repaving project provided its costs are reimbursed.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Kildeer, Lake County and State of Illinois, as follows:

Section 1. The foregoing recitals are incorporated into this Resolution as findings of the President and Board of Trustees.

Section 2. The President and Board of Trustees hereby authorize and direct the Village Engineer to enter into a letter agreement with the Village of Long Grove to repave Kildeer's portion of East Cuba Road and to reimburse the Village of Long Grove for the cost of repaving once the work is accepted by the Kildeer's Village Engineer.

Section 3. This Resolution will be in full force and effect from and after its passage and approval.

Re: East Cuba Road Resurfacing Agreement

Dear Mr. Lothspeich:

The Village of Kildeer has requested our review of contract documents, cost estimates, scope of work description and associated documentation related to the above referenced project. It is our understanding that the Village of Long Grove's 2011 Street Maintenance Program was recently awarded to Schroeder Asphalt Services, Inc. This project includes a section of East Cuba Rd. between Lakeridge Ct on the west and the McGinty Farm property on the east. Ownership and maintenance responsibility for this portion of East Cuba is evenly split between Kildeer and Long Grove with the eastbound lane being in the corporate limits of Kildeer and the westbound lane within Long Grove's village limits.

The cost estimate prepared by ESI for Kildeer's portion of East Cuba Rd described above is \$29,216.00. We understand this estimate is based on approximate quantities and that final costs will be based on actual quantities used to complete the work. We further understand that the Village of Long Grove will invoice the Village of Kildeer for their portion of the improvements upon completion of the work. Upon acceptance of the completed work, our office will recommend approval for payment.

The Village of Kildeer formally accepts and appreciates the opportunity and offer to participate in this project. Pavement rehabilitation along this section of East Cuba is certainly justified. It may be to both Village's advantage to develop an Intergovernmental Agreement in the near future to formalize jurisdictional responsibilities.

If any of the above is incorrect or requires clarification please let me know as soon as possible.
