**AN ORDINANCE REPEALING VILLAGE ORDINANCE NO. 2012-O-10  
RELATING TO THE VACATION OF A PORTION OF ARLINGTON HEIGHTS ROAD**

**WHEREAS**, Arlington Heights Road is a public right-of-way within the corporate limits of the Village of Long Grove (the "**Village**"); and

**WHEREAS**, on March 13, 2012, the Board of Trustees of the Village (the "**Village Board**") adopted Ordinance No. 2012-O-10, being "An Ordinance Vacating a Portion of Arlington Heights Road" (the "**2012 Vacation Ordinance**"); and

**WHEREAS**, under Section Five of the 2012 Vacation Ordinance, such ordinance would not be in full force and effect until several actions occurred, including the recordation of the 2012 Vacation Ordinance and a Plat of Vacation in the Office of the Lake County Recorder; and

**WHEREAS**, as yet, neither the 2012 Vacation Ordinance nor the Plat of Vacation relating thereto have been recorded in the Office of the Lake County Recorder; and

**WHEREAS**, because the required recording under the 2012 Vacation Ordinance has not yet occurred, the 2012 Vacation Ordinance still has not become effective; and

**WHEREAS**, the Village Board has received a request to repeal the 2012 Vacation Ordinance from residents affected by such ordinance; and

**WHEREAS**, the President and Board of Trustees of the Village have determined that it is in the best interests of the Village and its residents to repeal and rescind the 2012 Vacation Ordinance;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

**SECTION ONE:**     **Recitals.**     The foregoing recitals are by this reference incorporated into and made a part of this Ordinance as if fully set forth herein.

**SECTION TWO:**     **Findings.**    The Village Board hereby finds that the conditions precedent to the legal effectiveness of the 2012 Vacation Ordinance have not yet been satisfied. As such, the portion of Arlington Heights Road that was to have been vacated pursuant to the 2012 Vacation Ordinance has not been vacated and still remains a public right-of-way and part of the Village's municipal street system.

**SECTION THREE:**   **Repeal of 2012 Vacation Ordinance.**    The 2012 Vacation Ordinance, being Ordinance No. 2012-O-10 and entitled "An Ordinance Vacating a Portion of Arlington Heights Road," is hereby repealed and rescinded in its entirety, so that such 2012 Vacation Ordinance shall have no force or effect. The "Vacated Roadway" described in the 2012 Vacation Ordinance is and shall remain a public right-of-way and part of the Village's municipal street system.

**SECTION FOUR:**    **Effective Date.** This Ordinance shall be in full force and effect from and after its passage and approval form in the manner provided by law.
