**AN ORDINANCE ADOPTING BY REFERENCE
THE LAKE COUNTY WATERSHED DEVELOPMENT ORDINANCE**

WHEREAS, the County of Lake, pursuant to the powers granted to it by 55 ILCS 5/5-1062, adopted the Lake County Watershed Development Ordinance, establishing rules and regulations for floodplain and stormwater management throughout the County of Lake and superseding any less restrictive municipal rules and regulations therein ("**WDO**"); and

WHEREAS, the President and Board of Trustees of the Village of Long Grove have previously adopted the WDO codified at Title 4.1 of the Long Grove Village Code; and

WHEREAS, the County of Lake, pursuant to the powers granted to it by 55 ILCS 5/5-1062, adopted a resolution approving amendments to the WDO on or about July 10, 2012; and

WHEREAS, the President and Board of Trustees of the Village of Long Grove find it to be in the best interests of the Village of Long Grove to require all development to meet, at least, the minimum standards prescribed by the WDO to the fullest extent practicable; and

WHEREAS, three copies of the Lake County Watershed Development Ordinance, as most recently amended in July 2012, have been on file in the Office of the Village Clerk of the Village of Long Grove, and available for inspection, for not less than thirty (30) days;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

SECTION ONE. **Recitals.** The foregoing recitals are incorporated into this Ordinance as findings of the President and Board of Trustees.

SECTION TWO: **Adoption.** The Village Board of Trustees hereby adopts by reference, as if fully set out herein, the Lake County Watershed Development Ordinance, approved as amended by the County of Lake, State of Illinois, three copies of which have been, for a period of not less than thirty (30) days prior to the effective date hereof, and now are, on file in the office of the Village Clerk.

SECTION THREE: Governing Provisions. In the event that the rules, regulations, terms, or conditions imposed pursuant to the Lake County Watershed Development Ordinance are either more restrictive or less restrictive than comparable rules, regulations, terms, or conditions imposed by any other applicable rule, regulation, resolution, ordinance, statute, or law, then the most restrictive rules, regulations, terms or conditions shall govern.

SECTION FOUR: Amendment. Section 4.1-1-1, entitled "Stormwater Management Regulations Adopted," of Chapter 1, entitled "Watershed Development Ordinance," of Title 4.1, entitled "Watershed Development Regulations," of the Long Grove Village Code shall be, and is hereby amended in its entirety so that Section 4.1-1-1 shall hereafter be and read as follows:

4.1-1-1: STORMWATER MANAGEMENT REGULATIONS ADOPTED:

The Lake County Watershed Development Ordinance, as most recently amended by the County of Lake on ~~November 18, 2008~~ July 10, 2012, is hereby adopted by reference and is in full force and effect within the Village of Long Grove and is found in its own compilation.

SECTION FIVE: Amendment. Section 4.1-1-2, entitled "Penalty," of Chapter 1, entitled "Watershed Development Ordinance," of Title 4.1, entitled "Watershed Development Regulations," of the Long Grove Village Code shall be, and his hereby amended in its entirety so that Section 4.1-1-2 shall hereafter be and read as follows:

4.1-1-2: PENALTY:

Any violation of said provisions of the Lake County Watershed Development Ordinance, as most recently amended by the County of Lake on ~~November 18, 2008~~ July 10, 2012, shall hereinafter be considered a violation of this chapter. Any person who shall violate any of the provisions of this chapter shall, upon conviction, be fined not less than one hundred dollars (\$100.00) nor more than seven hundred fifty dollars (\$750.00) for each violation. A separate offense shall be deemed to occur for each day a violation occurs or continues. "Person", for the purposes of this chapter, shall mean and include any individual, corporation, partnership, association, or any other legal entity.

SECTION SIX: **Repeal.** All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

SECTION SEVEN: **Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form, as provided by law.
