**AN ORDINANCE AMENDING TITLE 8 OF THE VILLAGE CODE
REGARDING PRIVATE SEWAGE DISPOSAL SYSTEMS**

WHEREAS, the Village of Long Grove (the "**Village**") has adopted comprehensive health and sanitation regulations in Title 8 of the Long Grove Village Code (the "**Village Code**"); and

WHEREAS, the Village Code establishes minimum requirements for private sewage disposal systems; and

WHEREAS, in light of the permitting activities of the Lake County Health Department with respect to private sewage disposal systems, the Village has determined that it is unnecessary to maintain a local Health Commission to issue private sewage disposal permits; and

WHEREAS, the President and Board of Trustees have determined that it is in the best interests of the Village and its residents to amend the Village Code with respect to private sewage disposal systems as hereinafter set forth;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, COUNTY OF LAKE, STATE OF ILLINOIS, as follows:

SECTION ONE: Recitals. The foregoing recitals are by this reference incorporated into and made a part of this Ordinance as if fully set forth.

SECTION TWO: Amendment to Section 8-4-2 of the Village Code. Section 2, entitled "Health Commission," of Chapter 4, entitled "Private Sewage Disposal Systems," of Title 8, entitled "Health and Sanitation," is hereby deleted in its entirety, and such Section 8-4-2 shall hereafter be identified as "**Reserved**" for future amendments.

SECTION THREE: Amendment to Section 8-4-3 of the Village Code. Section 3, entitled "Application for Permit," of Chapter 4, entitled "Private Sewage Disposal Systems," of Title 8, entitled "Health and Sanitation," is hereby deleted in its entirety, and such Section 8-4-3 shall hereafter be identified as "**Reserved**" for future amendments.

SECTION FOUR: Amendment to Section 8-4-4 of the Village Code. Section 4, entitled "Number of Bedrooms," of Chapter 4, entitled "Private Sewage Disposal Systems," of Title 8, entitled "Health and Sanitation," is hereby deleted in its entirety, and such Section 8-4-4 shall hereafter be identified as "**Reserved**" for future amendments.

SECTION FIVE: Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval, posting, and publication in pamphlet form in the manner provided by law.
