**Ord. Amending Village Code Re: Residential Driveway Widths**

VILLAGE OF LONG GROVE

ORDINANCE NO. 2014-\_\_\_

**AN ORDINANCE AMENDING SECTION 7-1-1-5 OF THE  
VILLAGE CODE REGARDING DRIVEWAY WIDTHS**

**WHEREAS**, the Village Code of the Village of Long Grove currently restricts driveway widths to 18 feet; and

**WHEREAS**, due to changes in vehicle design, such restriction no longer serves the best interests of the Village and its residents;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, COUNTY OF LAKE, STATE OF ILLINOIS,** as follows:

**Section 1: Recitals.** The foregoing recitals are hereby adopted by the Village Board and incorporated into this resolution as if fully set forth.

**Section 2: Amendment to Section 7-1-1-5 of the Village Code.** Subparagraph (a) of Paragraph 3, entitled "Size," of Subsection (A), entitled "Driveway Specifications," of Section 7-1-1-5, entitled "Specifications," of Chapter 1, entitled "Streets, Sidewalks, and Public Ways," of Title 7, entitled "Public Ways and Property," of the Long Grove Village Code is hereby amended in its entirety, so that said Subparagraph 7-1-1-5(A)(3)(a) shall hereafter be and read as follows:

(a) Driveways Serving Single-Family Residential Uses: That portion of the driveway located between the vehicle access garage door and the right of way line shall be not less than eight feet (8') nor more than ~~eighteen feet (18')~~ **twenty feet (20')** in width. The ~~eighteen feet (18')~~ **twenty feet (20')** shall include decorative ribbons and any extension that adds to the general width of the driveway. No portion of the driveway entrance shall exceed a maximum width of twenty eight feet (28'), accommodating a minimum radius flare of three feet (3') and a maximum radius flare of five feet (5') on both sides of the driveway entrance at its intersection with the street.

**Section 3: Effective Date.** This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form in the manner provided by law.
