RESOLUTION WAIVING COMPETITIVE BIDDING & AWARDING A CONTRACT FOR  
VILLAGE SOCCER FIELDS IRRIGATION CONTRACT

**WHEREAS**, The Village Superintendant solicited quotes for the installation of lawn irrigation systems on Village Soccer Fields property, Old Hicks & IL Route 53 ("**Soccer Field Irrigation**") from three (3) lawn irrigation companies; and

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

**Section 1: Recitals.** The foregoing recitals are hereby incorporated herein as findings of the Village Board of Trustees.

**Section 2: Award.** The Village Board hereby waives competitive bidding and awards the contract for the installation of lawn irrigation systems on Village Soccer Fields property ("**Contract**") to **[INSERT COMPANY NAME]** in the total amount not to exceed **[INSERT \$ AMOUNT]**, as detailed in the Contract, and conditioned upon the receipt of all contractually required documentation and such other additional information that may be requested by the Village Manager in accordance with the Contract that is acceptable to the Village of Long Grove.
